



## Parent Guide To Boys & Girls Club Transportation

Dear Parent or Guardian,

Our goal is to safely transport your children home from Boys & Girls Club activities. It takes cooperation and responsible actions by each driver, student, and parent to achieve this goal. We rely on all students (supported by their parents or guardians) to follow procedures that contribute to the safety of everyone on the bus/van.

Please review the attached **Bus Rules** with your child. Each student must return the *signed Student's/Parent's Acknowledgement* form to the Boys & Girls Club. This will allow your student to receive uninterrupted transportation. Your acknowledgement lets us know that you have received this information and that your child is aware of the standards that have been implemented. We are requesting that you keep your contact information updated at the club with a telephone number where you can be reached if we need to contact you about your child's conduct on the bus. If you have any questions about any of these items, please discuss them with the Boys & Girls Club director, or call the Boys & Girls Club at **785-966-3031**. Failure to return the signed Acknowledgement Form *does not excuse your child* in the event disciplinary action is taken, and may result in bus privileges being denied.

Most students do a great job contributing to the safety of their buses/van. The daily bus ride is part of our members' education in learning to be good citizens by taking responsibility for their own behavior, safety and the safety of the other members on the bus. As we continue to grow, we need your continuing help to make sure that all students riding on our buses are as safe as possible.

# Safe Student Transportation Bus Rules

**NOTE:** *These rules apply to bus routes, field trips, and athletic trips.*

1. Obey and Respect the bus driver, other passengers and vehicle.
2. Never cross behind the bus.
3. Sit quickly and quietly in a seat.
4. Passengers are not to behave in any manner, which infringes upon the rights of any other passenger. This would include any form or type of bullying.
5. Wait until the bus comes to a complete stop and the door is opened before attempting to board or unload the bus.
6. Remain seated and face forward while the bus is moving.
7. The aisle is not to be blocked at any time.
8. No eating, drinking, chewing gum or spitting while on the bus.
9. Do not throw objects in, on, at, or from the bus.
10. Talk in normal tones; loud, rude, vulgar or obscene language/gestures are prohibited.
11. State law and/or Boys & Girls Club policy prohibit the following items on school buses:

Alcohol/drugs/tobacco	Glass items	Legally prohibited substances
Weapons	Lighters/matches	Other dangerous objects
Animals, insects or reptiles	Fireworks (including smoke and stink bombs)	
12. All items carried by students (i.e., band instruments, athletic equipment, backpacks, etc.) must be in their control at all times
13. All Varieties of Sport or Recreation Balls/ Equipment need to be enclosed in a backpack or sports bag.
14. Students will not be permitted to bring such items as Baseball Bats, Hockey Sticks, Golf Clubs, Tennis Rackets, Skateboards, Scooters or Roller Blades onto the bus. Any other object deemed to be unsafe cargo on the bus will be denied. The driver will have the authority to deny transportation to a student if such articles are in his/her possession.
15. Students are permitted to only board or exit the bus at their assigned stop. We will not drop off a member other than their own home unless a parent has called and requested a specific drop off place.
16. Complete silence is required in the vicinity of railroad crossings.
17. Student radios, CD players, etc. are not to be played loud on the bus.
18. Be alert for a danger signal (horn honking, verbal command, etc.) from the driver when leaving the bus or crossing a road. If you hear a signal immediately stop and check with the driver for instructions.
19. Littering is not permitted.
20. Use of aerosol products (hair spray, perfume etc.) is not permitted.
21. Behavior or conduct not listed above, which in the opinion of the driver is either unsafe or detrimental to the well-being of other passengers, is not permitted.
22. In the event that a parent or guardian is not home when a club member is dropped off, the member must stay on the bus until parent is contacted. If the staff is unable to contact the parent, staff must document attempts and contact Tribal PD and/or Social Services.
23. All members ages 5-7/special needs children must have parent come out and meet their child as they exit the bus.

## **Consequences for not abiding to transportation bus rules:**

**\*First Offense-3 day suspension of bus privileges**

**\*\*Second Offense-10 day suspension of bus privileges**

**\*\*\*Third Offense-Bus Privileges suspended for rest of year**

## Student's Acknowledgement of Responsibility for Member Transportation
