TERMINOLOGY

DOMESTIC VIOLENCE is a pattern of behaviors used to control another person. Abuse can be physical, emotional, sexual, psychological, and financial.

SEXUAL ASSAULT is any sexual contact made without consent.

STALKING is a pattern of behaviors that include unwanted attention, harassment or threats that cause a person to fear for their safety.

HUMAN TRAFFICKING is a crime involving the exploitation of a person using force, fraud or coercion for the purposes of compelled sex or labor.

ELDER ABUSE and mistreatment refers to any knowing, intentional, or negligent act that causes harm or creates a risk of harm to an older person by a family member, caregiver, or other person in a trusted relationship.

TEEN DATING VIOLENCE encompasses varying levels and types of abuse ranging from physical and sexual violence to forms of psychological and emotional abuse occurring between teens who are dating or are in romantic relationships with one another.
