ADMINISTRATIVE ORDER 2024-002

(Rescinding AO No. 2016-04)

Approving the PBPN Fish and Wildlife Fine/Bond Schedule
for the Title 18 Conservation Code

Pursuant to Section 2-2-6(A) of the Prairie Band Potawatomi Nation Law and Order Codes vesting authority in the Tribal District Court to “Be responsible for creating and maintaining the regulations and rules of the Court, not conflicting with the Tribal Codes for the orderly and efficient administration of justice. Such rules must be filed in the office of the Court Clerk before becoming effective.”

Pursuant to Section 2-2-7(B) of the Prairie Band Potawatomi Nation Law and Order Code, the Administrative Judge shall be responsible for the performance of any and all duties as may be required for the operation of the District Court.

Pursuant to Section 18-6-6 of the Prairie Band Potawatomi Nation Law and Order Code, the Court hereby adopts a Fish and Wildlife Fine/Bond Schedule for the Conservation Code, Title 18, violations, attached hereto as Exhibit “A”.

This will remain in effect until otherwise directed by further rules of the District Court or until amended by the Prairie Band Potawatomi Law and Order Codes.

This Order shall rescind prior Administrative Order No. 2016-04.
