**ADMINISTRATIVE ORDER 2024-004**

**(Rescinding AO No. 2017-03)**

**Approving Updated Court Fee Schedule**

Pursuant to Section 2-2-6(B)(1) of the Prairie Band Potawatomi Law and Order Codes vesting authority in the Tribal Court to “Be Responsible for creating and maintaining the regulations and rules of the Court, not conflicting with the Tribal Codes for the orderly and efficient administration of justice. Such rules must be filed in the office of the Court Clerk before becoming effective.”

The Tribal District Court hereby approves the updated Court Fee Schedule, last approved in Administrative Order 2017-03 (now rescinded), and the updated fee schedule is attached hereto.

This will remain in effect until otherwise directed by further rules of the District Court or until amended by the Prairie Band Potawatomi Law and Order Codes.


