(Non-Banishment Cases Only)

Pursuant to Section 2-2-6(B)(1) of the Prairie Band Potawatomi Nation Law and Order Code vesting authority in the Tribal District Court to "Be responsible for creating and maintaining the regulations and rules of the Court, not conflicting with the Tribal Codes for the orderly and efficient administration of justice. Such rules must be filed in the office of the Court Clerk before becoming effective."
